The Wisconsin Department of Corrections is releasing the following information pursuant to 1995 Wisconsin Statute 301.46(2m), which authorized the Department to inform law enforcement agencies of the release of a convicted sex offender when the release of information will enhance public safety and protection. Further, previous criminal history places him in a classification level which reflects the potential to re-offend.
