 SPECIAL BULLETIN NOTIFICATION**

The Wisconsin Department of Corrections is releasing the following information pursuant to 1995 Wisconsin Statute 301.46(2m), which authorized the Department to inform law enforcement agencies of the release of a convicted sex offender when the release of information will enhance public safety and protection. The individual who appears on this notification has been convicted or committed for an offense that requires registration with the Department of Corrections. Further, previous criminal history places him in a classification level which reflects the potential to re-offend.
